5.0 Build 89

The following enhancements are current in version 5.0 (Build 89), released April 9, 2018:

Data Integrity

Sanction now provides a way to create and manage multiple backup files. This new feature allows trial technicians to have multiple backups in case of corruption and helps prevent data loss.

__Duplicating Files

Updated changes to the user interface allow users to easily detect and edit their files in their presentation before and during a trial. This immediately alerts the user of any duplicate imports of transcripts and exhibit files, as well as the ability to choose what to name duplicate files being imported into your case.

<u>Case Editor</u>

Sanction now provides a built in Case Editor feature that provides a simpler way to manage data for presentations in Sanction. Users can easily make adjustments and bulk edits to the case using the new Find and Replace feature.

___Transcript Manager

Sanction's updated Transcript Manager is now built-in and allows you to easily modify elements of your transcript as you build your presentation.

Synchronization between Text Files and Video Files

Sanction has updated the methods to synchronize text and video files. This new feature allows users to easily set timestamps as well as export synchronized packages in various standard formats.

Known Issues

5.0 Build 89

The following issues are current in version 5.0 (Build 89), released April 9, 2018:

Backup only makes a copy of the XML file

When performing automatic backups, exhibit files, transcripts and media elements of the case are not backed up.

Fix: Manually save all files in the case directory to the same location.

Duplicate files are not detected when importing via drag and drop

When using the drag and drop feature, duplicates are not detected during the import.

Fix: Import files using the Import Wizard to be notified of any possible duplicate files.

Unable to edit timestamps without removing all

Timestamps are unable to be edited without removing all existing timestamps associated in the transcript.

Sanction 4

The following enhancements are current in version 4.0.

Drag and drop import

You can import items via drag and drop.

__Rotate pages and documents

You can rotate individual pages and entire documents.

Delete all annotations or exhibit stamps

You can delete multiple annotations and exhibit stamps at the same time.

<u>Create copies of exhibit pages</u>

You can save as many copies of an exhibit page as you want.

<u>Copy video files to the case folder</u>

You can run a command that copies to the case folder all of the video files referenced in your case.

<u>Find source items for items in a presentation</u>

After you add an item to a presentation, you can easily locate the item in your case folders.

<u>Font options for transcripts</u>

You can customize the font that is used to display transcripts.Â

Default edge of Tear Out tool

You can change the default border of tear outs to a jagged edge.

Column layout

You can adjust the column width, move columns, and sort by column for exhibits, and media.

New keyboard shortcuts

Numerous new keyboard shortcuts (hotkeys) have been added.

Known Issues

The following issues are current in version 4.0.

__Preferred Media Paths

In Sanction you can add Preferred Media Paths to a case and Sanction will search those directories for the media files in the case. You can optionally configure Sanction to search the subfolders of Preferred Media Path by selecting the Include Subfolders option. If this option is enabled, you must have access to all subfolders. If you do not have access to any of the subfolders, the search for the media file will fail.

___Tear Outs in Presentation Mode

Presentation Mode keyboard shortcuts are not available when the focus is in a Tear Out window. When you have a Tear Out window displayed while in Presentation Mode, for the Presentation Mode keyboard shortcuts to work, you must select the Presentation screen to give it the focus.

__Fast User Switching

Only one instance of the Sanction application can run on a single machine. Two or more users cannot simultaneously run Sanction on the same machine. Close the Sanction application prior to switching users.

Networks

Working on a case file located on a non-local network computer could cause corruption of the case backup file. It is highly recommended that you work only in case files held on your local computer.
