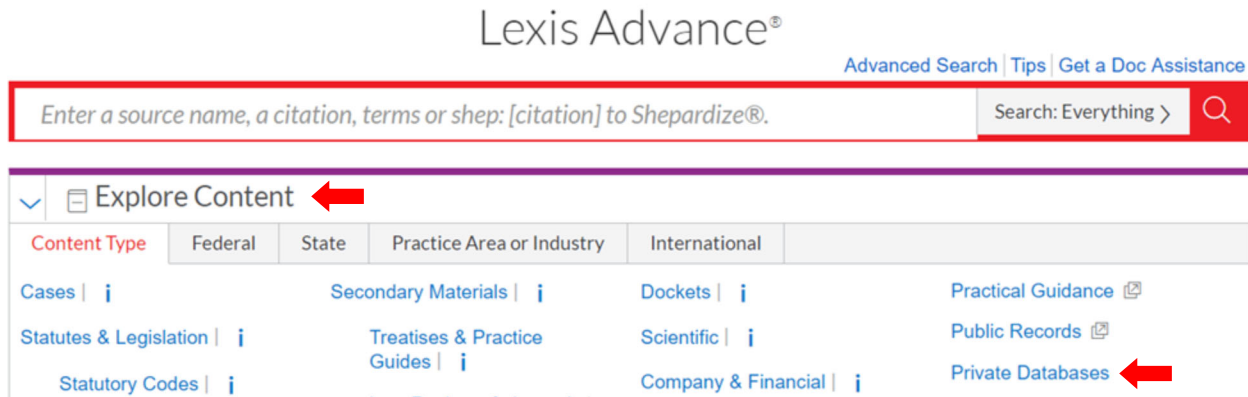

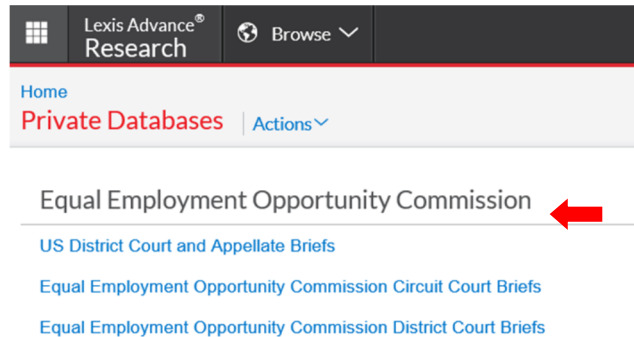

ACCESSING THE EEOC PRIVATE DATABASE FROM LEXI ADVANCE EXPLORE CONTENT

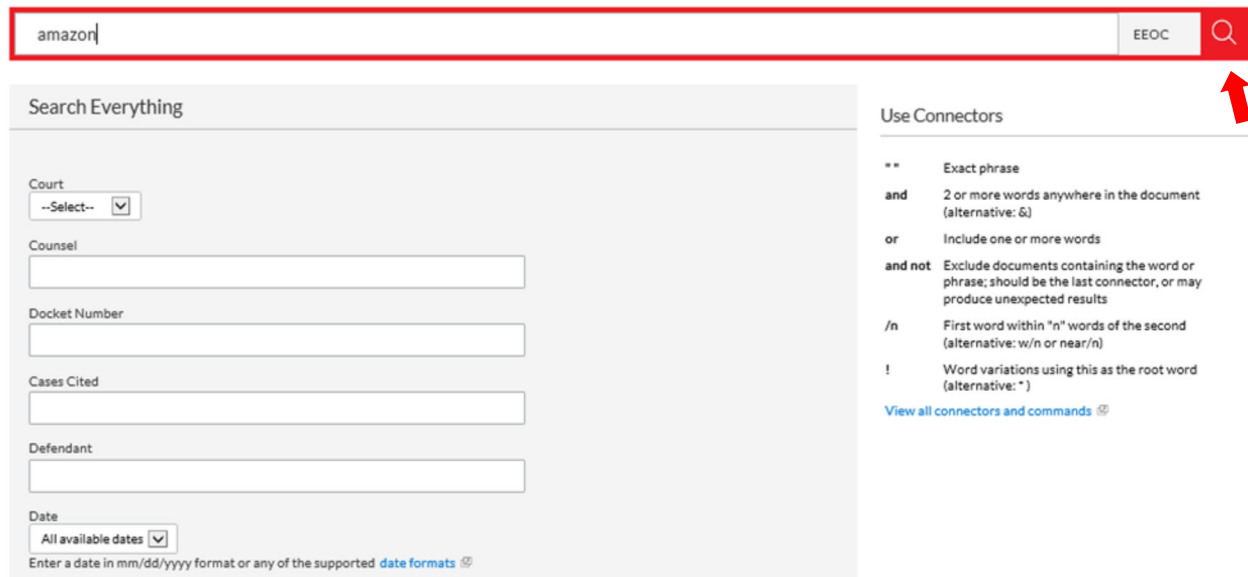
1 Access the EEOC Private Database via the Explore Content pod on the Lexis Advance homepage.



2 Once you click "Private Database," you will be brought to your Private Database page. Click the hyperlinked to go to the set of briefs you want.



3 This brings you to the Brief Bank search form. Enter your search terms on the form and click the "search" button.



4 The result set allows you to move between categories and filter on source, court, citations, and counsel.

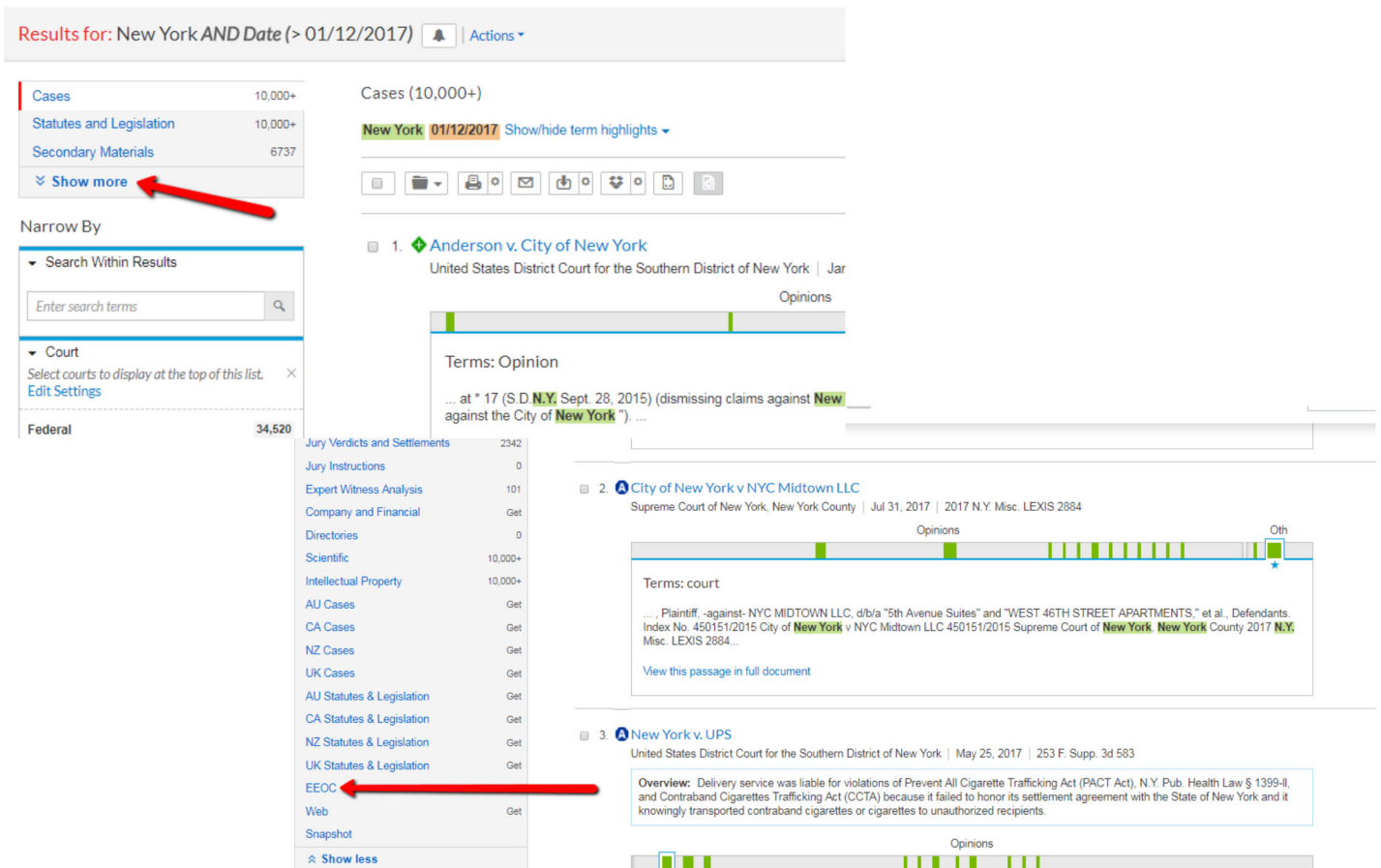
EEOC BRIEF BANK RESULTS FROM THE RED SEARCH BOX

Whenever you do a search from the Red Search Box on Lexis Advance, the EEOC Brief Bank will be one of the result set categories.

1 Type your search into the Red Search Box and Search Everything.



2 When the results are retrieved, the top result will be Cases. To narrow down to EEOC Brief Bank results only, select "EEOC" from the top right-hand menu. EEOC can be found by clicking "show more" and is the 3rd result from the bottom.



3 Once you have selected EEOC as a filter, you will see the EEOC Brief Bank results.
